Some of the things that happen around us today are so shocking and traumatic that we are apt to become impatient, and doubtful about the very existence of Allah.

It is only when we read his message in the Holy Quran that peace is restored to our hearts - for in the reading of the Holy Quran do our hearts find love and rest.

For instance the cruelty and injustice that some people in Power and Authority can inflict on those weaker than themselves. For example those cruel people who possess guns and explosives and are using them against the helpless and innocent ones. Even day to day happenings like serious motor accidents on the roads in which some people are so possessed by their own power of driving fast that they kill and injure innocent people who may have not have made any driving mistakes at all.

Allah's universal will and purpose is difficult for us to understand but we must be patient, and do our best to work deeds of righteousness - Allah has promised that he will bestow Love and Peace on those who believe in him.

Allah (Subhanahu wa Taala) says in the Qur'an: "Take not with me another God or thou (O Man) will sit in disgrace and destitution".

There is no excuse for man to seek other objects of worship than Allah – for there is none worthy of worship except Him. The foolish turn to false objects of worship. They will not only be disappointed, but they will lose the respect of their own fellow-men, and spiritually they will be reduced to poverty - All their talents and their works will be worthless.

"Thy Lord hath decreed that ye worship none, but Him, and that ye be kind to parents whether one or both of them attain old age in thy life. Say not to them a word of contempt nor repel them, but address them in terms of honour".

The spiritual and moral duties are now brought into one side. We are to worship none but Allah. The kindness to parents is an individual act of piety. They are not to be repelled or treated with disrespect, but shown every kindness in word and deed.

When the parents were strong they looked after the child – So when the child grows up and is strong he or she should return similar tender care to the parents More than that the children should approach the matter with gentle humility, for does not parental love remind them of the great love with which Allah cherishes his creatures? There is something here more than simple human gratitude. It reaches the highest spiritual regions.

Parental love is a type of divine love. Nothing that we can do can ever really compensate for that which we have received. Our spiritual

advancement is tested by this — We cannot perceive Allah's forgiveness if we are rude or unkind to those who unselfishly brought us up. Our prayer for our parents should be "My Lord bestow on them thy mercy even as they cherished me in childhood".

"Allah knows best what is in your hearts if ye do deeds of righteousness. Verify He is most forgiving to those who turn to Him again and again in true penitence".

It is the heart and its hidden and secret motives by which we are judged for Allah knows them all.

"And render to kindred (close relatives ) their due rights as also to those in want; and to the wayfarer. But squander not your wealth in the manner of spend thrift. Verily spendthrifts are brothers of Satan, and Satan is to his Lord Himself ungrateful".

# ISLAM AND THE RELATIONSHIP BETWEEN PARENTS AND THEIR OFFSPRING

A successful marriage usually leads to children. Parents and their relationship with their children is vitally important. So Islam has given both rights and duties.

The parents has the duties to give each child the equal opportunity to live. They must feed, cloth, shelter, nurse and care for it. A husband is to chose his wife well giving his children the best mother and vice versa to give them a good father. They have a right to be given a good and respectable name. Also a man must only marry a Muslim, Jewish or Christian wife and a woman a Muslim man (as the children are to follow the father's religion). The parents have a duty to teach the child about Islam, the Our'an and other vital knowledge the child needs to lead a successful life. "No father can give his child anything better than good manners". These are important duties not to be neglected. "Be careful of your duty to Allah and be fair and just to you children", (Hadith). The following story, titled, 'Hasn't a child rights over his father?", is from page 75 of "Islam the Natural Way" by Abdul Wahid Hamid, illustrates this. But a child also has duties and a parents rights. "Paradise lies under your mother's feet", goes the famous hadith. It means that a child must care for his/her parent's if she/he wishes to go to Paradise.

A man once came to Umar bin al-Khattab, the second Caliph, complaining about his son's disobedience to him. Umar summoned the boy and spoke of his disobedience to his father and his neglect of his rights. The boy replied: "O Amir al-Mu'minin! Hasn't a child right

over his father?" . "Certainly", replied Umar. "What are they Amir al-Mu'minin?. "That he should choose his mother, give him a good name and teach him the book (the Qur'an". "O Amir al-Mu'minin! My father did nothing of this. My mother Magian (fire worshipper). He gave me the name Ju'alaan (meaning beetle or scarab) and he did not teach me a single letter of the Qur'an". Turning to the father, Umar said: "You have come to me to complain about the disobedience of your son! You have failed in your duty to him, so he has failed in his duty to you; you have done him wrong before he wronged you".

"A man asked the Prophet, 'O messenger of Allah! Who deserves the best care from me?' The Prophet (مر) said "Your mother". The man said, "Who then?", the Prophet said, "Your mother". The man asked again and got the same reply. For the fourth tim he asked and the reply was "Your father", Hadith. This hadith explains that although you should love both parents you must hold your mother in higher regard, for of course, she did carry you for nine months, go through labour - a most testing time for the majority, suckle you and looked after you as a child. "And We have made it a duty for man to be good to his parents. His mother bears him with one fainting spell after another fainting spell, while his weaning takes two years. Thank me as well as your parents; towards Me lies the ultimate goal". (Qur'an). Allah is telling us here that by obeying our parents we are obeying Him, and we must remember that our ultimate goal of Paradise depends on us pleasing Allah. As a son/daughter you must obey your parents unless they go against Islam. "Your Lord hath decreed that ye worship none but Him, and that ye be kind to parents. Whether one or both of them attain old again thy life, say not to them a word of contempt, nor repel them but address them in terms of honour. And, out of kindness lower them the wing of humility and say: 'My Lord! Bestow on them thy Mercy even as they cherished me in childhood" (Qur'an 17:23-4). These verses are telling us that in your parents' old age in particularly you must care for them, cook and clean for them if they can't, make sure they have cloths, food and shelter, nurse them

when they are sick and basically care for their well being. The child mustn't be rude, or do things that upset or abuse their parents but respect them highly.

"A father's pleasure is Allah's pleasure, a father's displeasure is Allah's displeasure" (hadith). Here, we are being told that to please Allah we must please our parents, showing how we will get rewards from Allah if we please our parents, and his punishment if we annoy or anger them.

With these rules and guidelines Islam insures that the vital relationship between parents and their offspring is a sound loving one.

# A Muslim Home for Children in Need of Care in London

# AN APPEAL

MADINA HOUSE is a Muslim home for children in need of care, established in 1981 under the auspices of the Muslim Women's Association (a registered charity which has been functioning since 1962).

From its inception the organisers worked closely with the Department of Health and Social Security and all other Social Services Agencies in order to comply with the current guidelines on the running of Children's Homes. Subsequently Madina House was registered by the Department of S.S.I. under the Child Care Act.

Aim - The main aim of Madina House is to provide an alternative home for children who for whatever reason, are temporarily unable to live with their parent/s. At Madina House we provide a stable, caring background, founded on Islamic principles and practices. Since its founding we have cared for over 400 children.

The present home does no longer comply with today's regulations and we have been asked to find more suitable accommodation. Thus, we are in desperate need of finance to buy an appropriate building. Failing to do so, the future of Madina House is in question.

### KITCHEN TALK

# CHICKEN TIKKA AND VEGETABLES ON SKEWERS

Shahnaz Shah

#### Ingredients required:

Bitesize pieces of chicken breast 1 lb
Green/red/yellow peppers (half each cut in manageable pieces)
Button mushrooms – half lb
Courgettes 2 or 3 – cut in thin rings.
Tomatoes 2 or 3 cut in thick chunks

#### Seasoning:

Lemon juice 2 or 3 tablespoons Pepper/salt/chilli powder (optional – according to taste)

#### Preparation:

Marinade the chicken pieces in lemon juice/salt/pepper/chilli powder (for 10 to 15 mins) arrange the chicken + vegetables on skewers according to own preference

**Example:** courgette ring/yellow pepper/chicken piece/onion/tomato/green pepper/mushroom and repeat

### Cooking Instructions:

Grill or bake in moderate to high heat (turning skewers from time to time) for approximately 10 mins. presentation: serve with oven chips or on a bed of 'matar pilau'
